The Really Big Apple is Coming to Culver

Last week Apple announced that and workforce nationwide." Culver City was one of the new sites for a major office location. The company plans to house over 1,000 employees at the new location. The Culver City site is part of a major expansion including an investment of \$1 billion to build a new campus in North Austin. and new sites in Seattle, San Diego as well as Culver City.

"Apple is proud to bring new investment, jobs and opportunity to cities across the United States and to significantly deepen our quarter-century partnership with the city and people of Austin," said Tim Cook, Apple's CEO. "Talent, creativity and tomorrow's breakthrough ideas aren't limited by region or zip code, and, with this new expansion, we're redoubling our commitment to cultivating the high-tech sector

Apple had already announced plans to occupy the office complex at Washington Blvd. & National Ave. after HBO backed out of that deal.

The move follows Amazon Studios move into the historic Culver Studios complex. Hackman Capital Partners, which owns Culver Studios, says that Amazon has also agreed to lease 75.000 square feet of office space at the Culver Steps development that Hackman is building.

Amazon will end up occupying more than 350,000 square feet of space in Culver City for its production arm, as well as the company's video and advertising departments and the movie reference site IMDb, which Amazon

Councilman Lee Joins 300 Elected Officials in Calling for Plan to Phase Out Fossil Fuels

Culver City Councilman Daniel Lee has joined more 300 elected officials from 40 states in calling for the phasing out fossil fuels and a green new deal approach.

Reiterating the concerns of millions of Americans whose health and safety is threatened by fossil fuel production and worsening impacts from climate change, Councilmember Lee along with more than 300 mayors, state representatives, and elected officials have released a letter calling for a nationwide plan to phase out the production and use of fossil fuels and to ramp up renewable energy.

umbrellas, searching for proper identification to present at the gate. After the all clear, we were escorted up the driveway to the James Brady Press Room in the West Wing.

This was the very spot that has served as the public forum for the presidency. Dozens of cameras and White House Correspondents stood collecting all the factual and sensory information they could acquire. I was excited to be just a few feet away from the Oval Office knowing that I was in the heart of Washington D.C. and among people who were involved with pressing issues of this country on a daily basis. It was awe-in-

I was there to participate in the 2018 Press Preview of the White House holiday decorations. It's an annual event, hosted by the First Lady, and I was one of two lucky student reporters representing Kid Scoop Media.

We had some time in the press room before heading out with all the reporters to enter the White House. A long hallway was lined with beautiful, dark red Christmas trees which led the way to three differently decorated state rooms.

As I climbed the nearby stairs, I saw dozens more Christmas trees incredibly decorated in a more traditional style. The room was enlivened by the United States Marine Band performing Christmas music that echoed through the historic mansion. I was blown away by all the beauty and history that stood before me, and I sensed everyone else felt it, too. It was traditional, elegant, and magical.

We hustled quickly back through the rain to the briefing room. I waited in anticipation for what was next to come. I felt so honored being in the mix of the prominent journalists. In their companv. I was able to learn more about what it meant to be a reporter in a 24-hour news cycle era.

After a short couple of hours, we were escorted to the South Lawn just adjacent to the Rose Garden. A huge gust of wind almost knocked me over. As I looked up, Marine One was slowly landing on the lawn. It was loud and enormous. The scene was spectacular with the iconic Wash-

ington Monument in the background. We were all waiting excitedly for the President to appear.

President Trump exited the Oval Office and made his way over to the group of reporters to answer questions before boarding the helicopter I could not believe my eyes! The President was just an arm's reach away. He made his wav closer to us

as he headed towards the helicopter, and our smiles widened. I never expected to be so fortunate to see the President in real life.

I brought home a red MAGA hat to serve as a reminder of the greatest day of my life. I have never felt so lucky and thrilled to have had the chance to observe something so important. I was in awe of how amazingly beautiful the White House was decorated by the First Lady. Every detail was thought out. Although we were not able to see the First Lady in person, her decorations certainly got me in the Christmas spirit!

The moment I will forever cherish was being able to see President Trump. We were informed that he was headed to a rally in Mississippi, and we were able to see him leave on Marine One. Before he left, though, he came over to the press

area and answered questions. I wasn't close enough to introduce myself or talk to him. but I listened to what he had to say. Just being in his presence was an honor.

Once Marine One took off, we went back to the press room and were surrounded by newscasters relaying the President's message about strengthening our borders. Being able to see President Trump and hear him talk on current issues in our nation was more than fascinating. Not only did I learn a lot more about what is going on in our world, but I learned so much about the media. I never realized how much time journalists put into their work until I saw them running back and forth, changing the lighting, rehearsing what to say, and so on. The news is always on in my house, but it never really drew my attention. I am much more interested and intrigued in the whole process now. Seeing everything first hand is so different from watching it on the television or seeing pictures or videos on the internet.

Along the way, we met a cameraman who made our tour even more enjoyable. He introduced us to journalists, other cameramen, news station teams, and even President Trump's political consultant, Kellyanne Conway. Everyone involved in this event was more than generous in sharing their experiences and the roles they play in our government and reporting the news.
